Family business

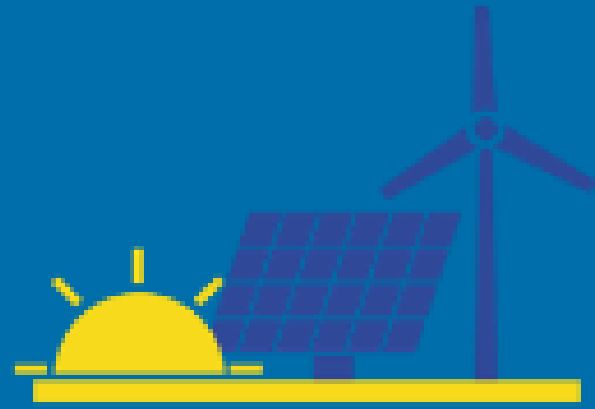
FEH is **100% in hands of a German owner** with Chinese roots and currently led by the first and second generation. Member of the German association for family businesses

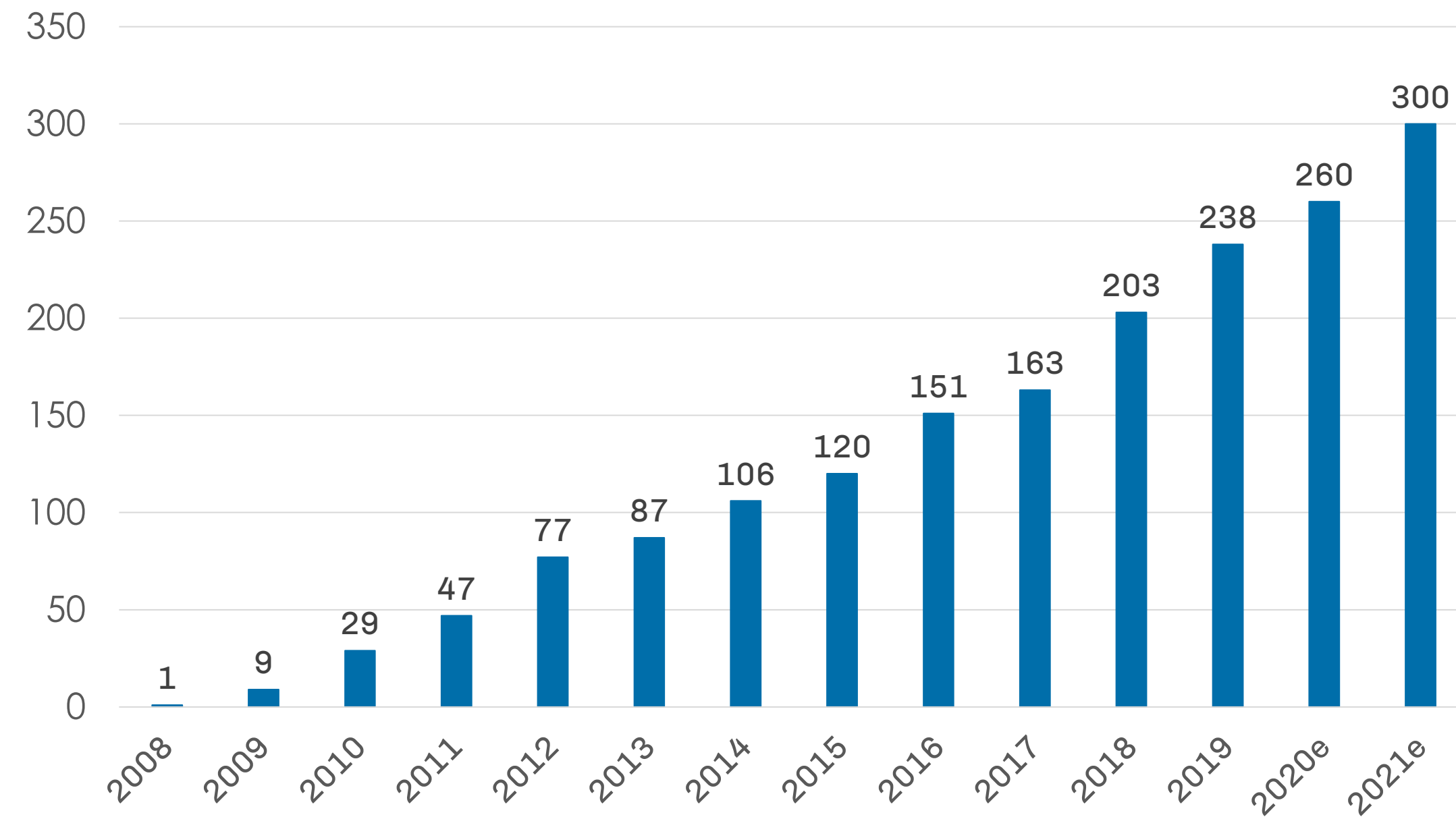

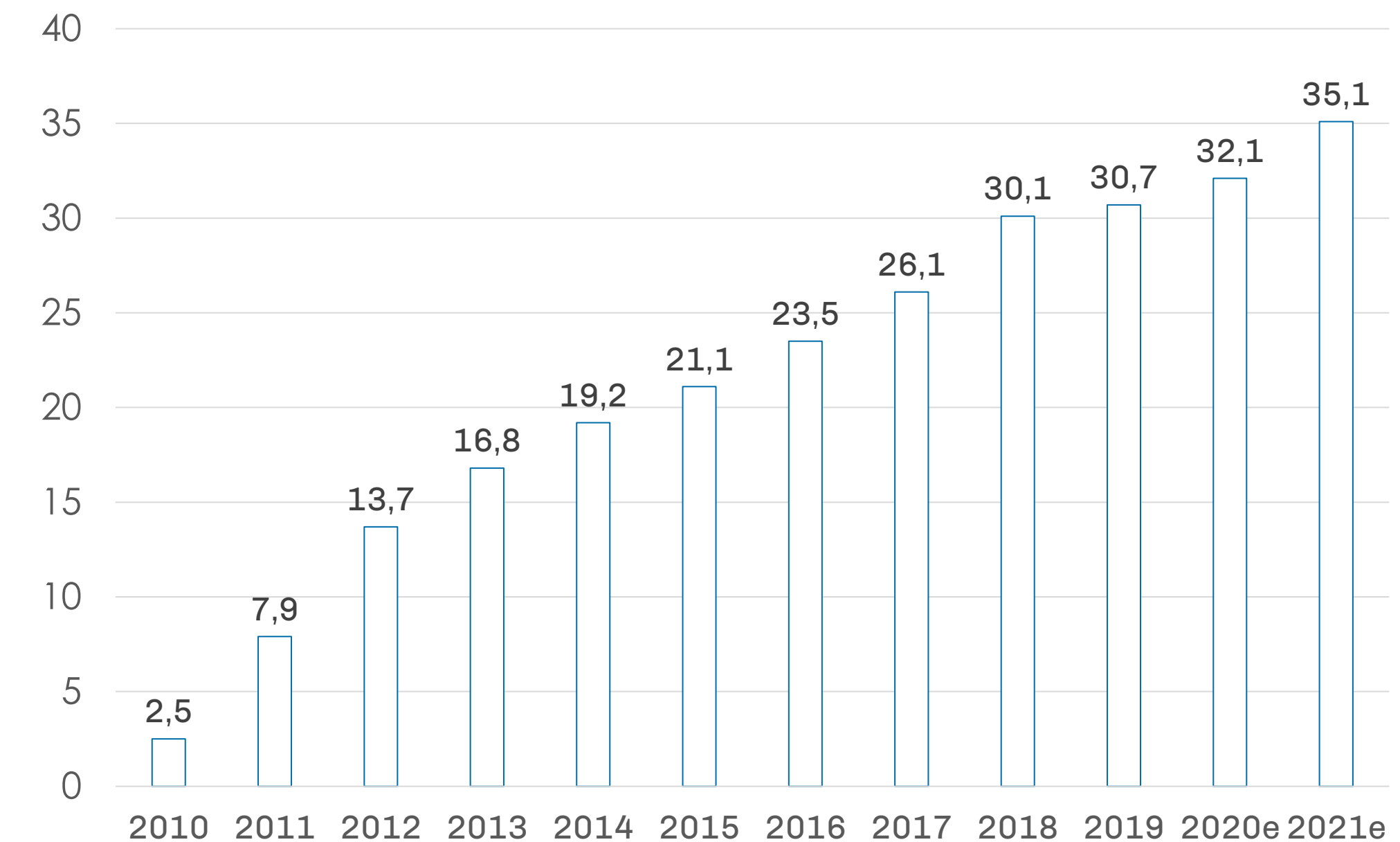


A strong asset base is our corner stone for increasing revenues

Steady income and sustainable business model:

97% of all PV plants are located in Germany and approx. 3% in other EU countries

Frankfurt Energy Holding – Value Chain in Solar Power

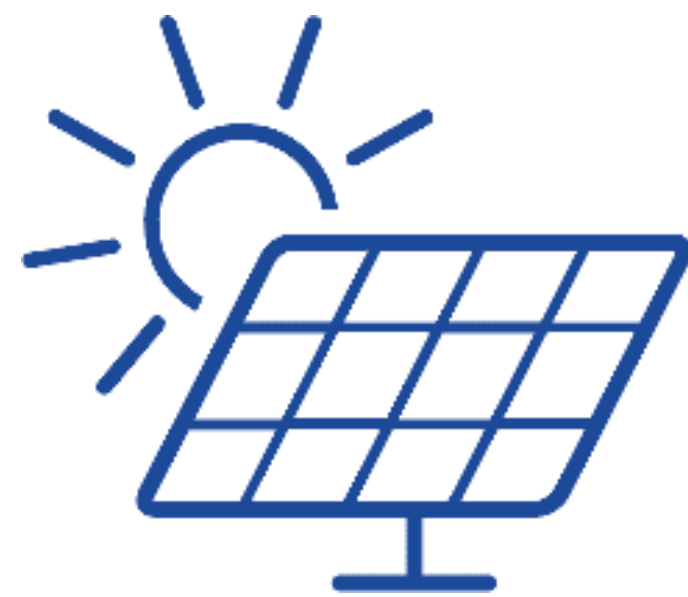


Coverage of all elements of the value chain for enhanced efficiency



Engineering, procurement & construction (EPC) of PV power plants and battery storage projects

Own development of projects as well as coordination of business partners and subcontracted EPCs
EPC exclusively for own investments of the FEH-group from two locations in Germany
Direct supply of all electronic components from Asia (China)



Independent power producer (IPP)

Commercial management for all SPVs as well as reporting for banks and other debt investors
Monitoring, operation and maintenance (O&M) for all own PV power plants in Germany
Proprietary performance analysis und direct marketing through trading partners



Long-term investor

Parent company, FEH GmbH (fiscal unity with almost all SPVs)
Currently approx. 115 SPVs with between one and up to 15 PV plants
Development of new porjects as well as purchase of existing power plants
Financial engineering and structuring of project and corporate finance facilities
